

RESOLUTION NO. 1406

A RESOLUTION OF THE CITY OF ENUMCLAW, KING COUNTY, WASHINGTON
REQUESTING KING COUNTY PLACE ON THE APRIL 26, 2011 BALLOT THE
QUESTION OF ANNEXATION TO THE KING COUNTY LIBRARY SYSTEM

Whereas, the City of Enumclaw ("City") has for many years provided library services to its citizens; and

Whereas, the City due to current fiscal constraints is no longer able to provide the desired level of library services to its citizens; and

Whereas, continuing library services is of great importance for the many educational and societal benefits it affords city residents; and

Whereas, in the interest of preserving a reasonable level of library services for its citizens, the City finds it prudent to put forth to voters the question of annexation to the King County Library System ("KCLS"); and

Whereas, KCLS has since 1942 provided library services throughout unincorporated King County and to the towns and cities who have annexed into it; and

Whereas, the City passed resolution no. 1396 expressing interest in annexation; and

Whereas, KCLS passed resolution no. 2012-12 expressing interest and willingness to pursue annexation; and

Whereas, if the voters of the city approve the annexation measure, KCLS will become the sole provider in the City of library services; and

Whereas, the City requests King County take the necessary legislative and procedural action to place the question of annexation on the April 26, 2011 ballot.


Now, therefore, the City Council of the City of Enumclaw, King County, Washington does hereby resolve as follows:

Section 1: A copy of this resolution, and any other necessary materials, shall be timely submitted to King County as notice of the City's desire to pursue annexation to KCLS.


Section 2: The City Council respectfully requests that the King County Council take the necessary legislative action to pass an ordinance for the purpose of placing on the April 26, 2011 ballot the question of annexation to KCLS.

Section 3: If any provision of this resolution, and/or Agreement attached, is determined to be invalid or unenforceable for any reason, the remaining provisions of this resolution and/or the attached Agreement shall remain in force and affect.
