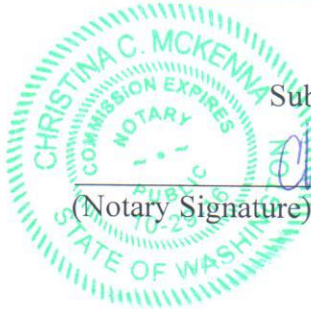

Ordinance 18186

NOTICE IS HEREBY GIVEN that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington, on January 25, 2016 at 1:30 p.m. The purpose of this public hearing is to receive public testimony relating to Ordinance 18186, which adopted findings in support of a moratorium and renewed for six months an existing moratorium on the establishment or location of medical marijuana dispensaries and collective gardens asserted to be or actually authorized under Chapter 181, Laws of Washington 2011, and chapter 69.51A RCW.

Background

Ordinance 18186 was adopted on December 7, 2015. A public hearing within sixty days of the enactment of a moratorium and the adoption of findings is required by RCW 36.70A.390. This hearing is only for public testimony on the moratorium.
