1 A MOTION authorizing the King County executive to
2 accept a donation of twenty-five thousand dollars, to meet
3 the needs of recently arrived refugees impacted by events
4 in Afghanistan.

5 WHEREAS, in fall 2021 King County welcomed nearly one hundred seventy five
6 refugees impacted by events in Afghanistan to Federal Way as they resettle in the United
7 States, and

8 WHEREAS, King County provided temporary housing for the refugees at a
9 county-owned former hotel property while the refugees await placement in permanent
10 housing, and invested County funds in language supports and grants to community-based
11 organizations supporting the refugees, and

12 WHEREAS, those refugees have arrived without resources for basic needs like
13 clothing, children's items, personal care items and food, and

14 WHEREAS, under K.C.C. chapter 2.80, gifts, bequests and donations that exceed
15 two thousand dollars require acceptance on behalf of King County by the King County
16 council by motion, and

17 WHEREAS, the donor, Amazon.com, Inc., would like to make the donation to
18 King County to meet basic needs of refugees impacted by events in Afghanistan who are
19 staying at the county-owned former hotel;

20 NOW, THEREFORE, BE IT MOVED by the Council of King County:

21 The King County executive is authorized to accept a donation of twenty-five
22 thousand dollars from Amazon.com, Inc., to meet the needs of recently arrived refugees


