1 AN ORDINANCE authorizing the manager of treasury
2 operations of King County to cancel the attached list of
3 uncollectible personal property taxes in the amount of
4 \$778,647.94 for the years 2009 through 2017.

5 **STATEMENT OF FACTS:**

6 1. The duly appointed manager of treasury operations of King County,
7 Washington has made an affidavit pursuant to the terms of RCW
8 84.56.240 and 84.56.260 to the King County council relating the
9 manager's diligent search and inquiry for goods and chattels of the persons
10 appearing on the list of delinquent taxpayers and the manager's inability to
11 find any such property from which the taxes could be collected.

12 2. The duly appointed manager of treasury operations of King County,
13 Washington, has requested that the King County council cancel the taxes
14 consistent with RCW 84.56.240.

15 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

16 SECTION 1. The taxes in the amount of \$778,647.94, as indicated in
17 Attachments A, B and C to this ordinance, from the records of treasury operations for the
18 years 2009 through 2017, shall be cancelled, but the obligation to King County is not
19 forgiven. The manager of treasury operations of King County is hereby authorized to

20 cancel the taxes on the tax rolls.


