The King County Assessor recommends reducing the assessed value of subject property for the 2000 tax roll from \$32,000 to \$4,000 based on a manifest error where the 2000 value was based on the incorrect assumption that this parcel was a buildable site, when in fact it was not a buildable site.

The Assessor has corrected the 2001 and 2002 tax rolls. This parcel was merged to another parcel for the 2003 and subsequent tax rolls.

The taxpayer also petitions for tax relief for the 1996 thru 1999 tax rolls.

The Assessor recommends no change to the 1996 thru 1999 tax rolls, as subject parcel was correctly valued as an unbuildable site for these tax years.
