**Call to Order**

*The meeting was called to order at 1:41 p.m.*

**Roll Call**

**Flag Salute and Pledge of Allegiance**

*Mr. Dunn led the flag salute and Pledge of Allegiance.*

**1. Approval of Minutes of March 5, 2007**

*Ms. Patterson moved to approve the minutes of the March 5, 2007 meeting as presented. Seeing no objection, the Chair so ordered.*

**2. Reports on Special and Outside Committees**

*Ms. Patterson reported on the March 8, 2007 meeting of the Transportation Policy Board. The Board reviewed a series of transportation policies to include in its Vision 2020 update, this region's long term plan for transportation. The Puget Sound Regional Council will continue to coordinate updates to its long range plan.*

*Mr. Constantine reported on the Sound Transit Board. The Board adopted a new fare structure and fares for Sounder commuter rail. The Board approved a change from the zone fare structure to a distance based structure. The Board also approved a ten percent increase in the Sounder fares. This increase will allow the agency to come closer to reaching its goals for fare box recovery. A main topic of discussion was governance legislation currently in the Legislature. Board members expressed serious concerns.*

*Mr. Phillips commented, indicating he concurs that this is not the time to be changing the structure for Sound Transit, and that the Chair of Sound Transit also has indicated that the bills being considered in Olympia will not be helpful.*

*Ms. Patterson reported on the Regional Transportation Investment District Executive Board. The Board was briefed by staff on the formation of an expert panel to review the financing plan. The Board took public testimony in order to gather public input on the plan which will be on the ballot this fall. Ms. Patterson commented on the Town Hall meeting taking place later this evening regarding the road and transit plan.*

*Ms. Hague also made comments and encouraged participation.*

*Ms. Hague reported on the Eastside Transportation Partnership. The members received a briefing on the RTID/Sound Transit package and agreed on a position paper to send to those bodies outlining areas of support. They also received a briefing on the governance package to the Legislature. The members also finalized their legislative package and work program.*

### 3. **Plat Tracing**
