A MOTION approving the records, elections and licensing services division response to the 2003 budget proviso requiring submission of a report identifying animal control customer service improvements and answering specific questions about the field canvassing program.

control staff and the areas to be covered in the future and the schedule; a proposal for
collecting license fees in the rural unincorporated area in a more efficient manner; and the
projected actual revenues and expenditures of the canvassing program for 2002 and a
projection of canvassing revenues and expenditures for 2003," and



## **Animal Control Customer Service** and

### 1. PROVISO

The 2003 King County Adopted Budget contains the following proviso:

"Of this appropriation, \$159,000 shall not be expended or encumbered until the executive has submitted and the council has approved by motion a report identifying ways in which he intends to improve animal control customer service. At a minimum. the report should include: a description of the policies and procedures in place for handling customer complaints; a description of the policies and procedures that are followed to protect against invasion of privacy and damage to private property by animal control staff; the measures used or to be used to clearly identify both personnel and vehicles as being official King County animal control equipment or employees; a description of the geographical areas that have previously been canvassed by animal control staff and the areas to be covered in the future and the schedule; a proposal for collecting license fees in the rural unincorporated area in a more efficient manner; and the projected actual revenues and expenditures of the canvassing program for 2002 and a projection of canvassing revenues and expenditures for 2003. The report should be filed with the council clerk no later than February 15, 2003. The original and 15 copies of the report must be filed with the clerk, who will retain the original and will forward copies to each councilmember and to the lead staff for the labor, operations and technology committee."

### 2. BACKGROUND

King County has provided Animal Control Services to nearly all suburban cities and unincorporated King County areas since 1972 (Attachment 1). Services to most suburban cities have been arranged through interlocal contracts with individual cities in which King County has provided these services at no direct cost to the cities. In exchange, King County keeps all pet licensing fees. Additionally, the County receives and retains other moneys collected within those cities associated with animal control services such as pet adoption fees, redemption and kenneling fees, and fines.

Historically, expenditures for the Animal Control Services program have exceeded revenues with the shortfall/subsidy coming from the County's Current Expense Fund.

The suburban cities that contract with the County have consistently resisted the idea of being directly charged for their animal control services provided by the County. They have supported the County's pursuit of full cost recovery through increased license sales and thereby increased revenue to the County. Increasing the number of licensed pets in a unified countywide system is believed to be an effective approach to improving services

to the public. This approach is expected to better facilitate the location of animals and 1725 senhance the ability to respond appropriately to complaints as well as ensuring an adequate funding level for this vital program.

### 3. FIELD CANVASSING PROGRAM

In June 1992, the King County Council adopted Ordinance 10423 making substantial changes to the animal control code. The legislation used a multi-pronged approach to achieving its goals which included public education, promotion of spaying and neutering, and increasing pet licensing through a field canvassing program. In 1999, the field canvassing program was expanded in an effort to increase pet identification in King County while establishing financial self-sufficiency for King County's regional animal services, recovering its costs through pet license sales. This enhanced initiative is called the Pet Partnership Program.

The field canvassing program is embodied in King County Code, Section 11.04.580 and includes the direction that:

"the animal control authority shall develop and implement a twelve month program to canvass for compliance with the licensing requirements of this chapter [pet licenses]. The program shall be directed to households within unincorporated areas of King County and cities under contract with King County for animal control services. Animal control authority employees and persons or organizations under contract to the animal control authority performing the canvassing shall have the authority to issue pet licenses and collect license fees."

The field canvassing program has historically been a key source of new pet license sales, and with the development of the Pet Partnership Program, canvassing efforts were amplified to help fulfill the program's cost recovery goals. Although canvassing has been ongoing since 1993, there continue to be pet owners who are not aware of the law or the benefits of licensing their pets, or who have previously successfully avoided licensing requirements.

The field canvassing program is staffed with a permanent canvass coordinator and temporary employees who provide education at community events, fairs and malls and door-to-door. This sales team is trained to use effective, customer-friendly approaches that inform the public on the value and importance of pet licenses. Canvassers explain the County and city laws requiring licenses for dogs and cats and describe the many important benefits of licensing and identifying pets. They also inform pet owners that pet licenses help assure the safety and protection of their animals by reuniting lost pets with families. If the homeowner has a pet whose license has expired, the canvasser is able to renew the license to maintain the record and assure it is current and accurate.

Field canvassers are trained to issue required new or renewal pet licenses while they are at the residence provided there are no extenuating circumstances. Experience shows that this is the most efficient approach. This practice avoids the need to utilize additional resources dedicated to follow-up and also helps in minimizing delays in placing the pet in the County's identification system increasing the pet's safety and protection.

A variety of incentives and tools have been used by canvassers to assist and appeal to the pet owners:

- Pet owners licensing more than one pet for the first time can take advantage of a special "buddy license" promotion: buy one license at the regular full price and the second license can be obtained for only \$5.00.
- Pet owners can opt for a voucher for a microchip implant for their pet with the purchase of a new full price license.
- Pet owners who do not have funds available at the time of a canvasser visit can be provided with temporary pet licenses valid for up to 90 days at no charge. Although the program's goal is to issue the regular annual license, the priority is to identify and license the pet, so the free temporary license is a helpful tool. These temporary licenses can then be renewed and paid for at a later date through the mail or at any of over 100 community sales locations (Attachment 2).

Results of field canvassing and licensing follow up visits are as follows:

Canvassers proceed door-to-door through residential areas throughout the year with hours as follows: Saturdays from 9 a.m. to 6 p.m., Sundays from 11 a.m. to 6 p.m., and Monday through Friday 12:00 noon to up to 9 p.m. (depending on time of year). The purpose of weekend canvassing is to reach the largest number of people possible. The canvass program includes Saturdays and Sundays as regular scheduled workdays so that there is no additional labor cost for providing services on weekends. City halls and police departments are informed when canvassers are in their areas.

### 4. HANDLING CUSTOMER COMPLAINTS

Our goal is to prevent complaints through professional and courteous services. When complaints do occur, they are handled and resolved promptly and at the lowest levels possible.

If a customer raises a concern directly to a field canvasser during a home visit, it is addressed immediately if possible. The most common question raised deals with the need to license a pet. Canvassers are trained to respond professionally and with good customer service skills. For pet owners questioning the need to obtain a license for their pet (or renew an expired license), the canvassers explain the County and city laws requiring all dogs and cats be licensed and emphasize the many benefits of pet licensing. Canvassers are equipped with pamphlets and resource materials to help provide information to the public. They carry cellular telephones and are directed to consult with a supervisor from the field if needed to appropriately respond to the customer's questions.

If the canvasser does not satisfactorily resolve a customer's questions or concerns, they will refer the customer to the Field Canvassing Program Coordinator. Canvassers now carry the Canvass Coordinator's business cards and will provide one to the customer whenever appropriate or upon request. If the Canvass Coordinator receives an inquiry from a member of the public and cannot satisfactorily resolve the concern, the matter is referred to the Animal Services and Programs Manager.

In all cases, the goal is to provide helpful customer service and to represent the program professionally and positively. Telephone messages are returned promptly, and written messages (letters or e-mails) are responded to in writing in the same manner.

If a customer or member of the public calls directly to the Animal Control Call Center (206-296-PETS), the operators apply the following procedures:

- The operator attempts to resolve the question or concern and assists the caller if possible.
- The operator forwards the caller to the lead when necessary. The operator will
  automatically forward the call to the lead if there is a high call volume in order to
  avoid being or sounding rushed.
- If necessary, staff gathers information and contacts the proper authority (e.g., Animal Services manager, Animal Control sergeants, or Shelter supervisor) or forwards the customer directly to them.
- Staff provides direct phone numbers or direct extensions (for the automated phone tree) to the customer.
- Staff stays in contact with the customer until the complaint is properly forwarded or resolved.

Call Center staff are given news bulletins, brochures, and information sheets (King County and other agencies) to help them assist with phone calls or to mail to customers.

### 5. PROTECTING CUSTOMER PRIVACY AND PROPERTY

Customer privacy and security is an important priority of the field canvassing program. Staff are trained to recognize that they are visiting the public at their homes, and their visits should therefore be professional, positive and brief.

Canvasser safety is an important priority of the field canvass program. Program procedures include the direction that, "canvassers should examine the yard areas of each house before proceeding into the property being on the lookout for hazards, aggressive animals or other possible issues." Canvassers are directed that they "must stay on established walkways and pathways when approaching doorways [and] may not look in windows or go behind houses to inspect yards." However, canvassers are to remain alert for obvious signs of pets (e.g., food dishes, chew-toys) in order to assess if pet licenses may need to be issued at that property.

If after knocking or ringing the bell and no one responds, field canvassers leave a door hanger (Attachment 3) on the doorknob or tucked into the door jamb. This is a specially designed flyer intended to inform the residents that the canvasser has visited and includes helpful information and a license application that the resident can mail in.

Canvassers are directed to not enter the homes that they visit and to politely but firmly decline any offers of food or drink.

Canvassers are directed to interact only with adults at any home that they visit. If a child answers the door, the canvasser may ask if an adult is present. If none is available, the canvasser leaves information that explains the visit and then leaves.

The field canvassing program has not received any complaints regarding damage to private property; however, to assure that any concerns can be addressed, a section on this issue has been added to the program procedures, and staff will receive training on the subject. These steps are as follows:

Canvassers must exercise care and caution while on private property. If a canvasser causes any damage to private property while on duty, the following steps must be followed:

- 1. The incident must be clearly documented on the Field Canvassing Tracking Sheet. Documentation includes the location and nature of the damage, how it occurred and if the homeowner was home at the time of the incident.
- 2. The canvasser must: notify the homeowner, provide the owner with information on how they can contact the Canvass Coordinator, and inform the homeowner that the County provides a process where they can file a claim for damage. If the homeowner is out, notification must be left at the door.

- The canvasser must also notify the Canvass Coordinator (leave a voice mail
  message if necessary). The Canvass Coordinator will inform the canvasser if an
  incident report is required.
- 4. The Canvass Coordinator will notify the Manager of Animal Services and Programs Section, of all incidents where damage to private property may have occurred.

Canvassers document their activities on a Field Canvassing Tracking Sheet. They list every home visited, whether someone was home, whether pet licenses were issued, and note any useful information for the records or for follow up. The Canvass Coordinator reviews all Tracking Sheets.

### 6. IDENTIFYING PERSONNEL & VEHICLES

Properly identifying canvassers as King County representatives so that homeowners can be assured of the legitimacy of their visit is a very important matter.




Canvassers carry official King County photo ID, which is clipped to the collar (as pictured above) or worn on a colorful lanyard around the neck.

Canvass uniforms consist of royal blue polo shirts and/or windbreakers with "King County Pet Licensing" screened on the fabric (in inclement weather these may be under heavier jackets or raincoats). The canvasser pictured above is wearing the program's uniform shirt with his King County photo ID clipped to the collar.

Canvassers are also issued an additional piece of King County photo ID that they typically carry in a wallet or pocket. The ID can be shown to customers, as needed, as additional demonstration of their legitimacy and identity.



Most canvassers use their private vehicles and are provided with magnetic signs that adhere to the outside of the vehicle. These signs are approximately 18" x 24" and say "King County Pet Licensing" as pictured below.



Clear or translucent plastic signs that adhere to the inside windows of canvasser vehicles are provided as alternatives to the exterior signs, as shown by the examples pictured below.

### 8. COLLECTING LICENSE FEES IN RURAL AREAS

The marketing and selling pet licenses occurs through a variety of strategies so that the public has a range of convenient options and opportunities to identify and license their pets. Through this array of diverse options and strategies, residents of urban, suburban and rural communities can take advantage of many different licensing methods.

These strategies include options that allow residents of rural areas to efficiently license their pets from their homes or at convenient local locations:

- Website. The King County website includes an application enabling pet owners to apply for a free 90-day pet license. In the latter half of 2002, the Office of Information Resource Management (OIRM) initiated an e-commerce pilot program consisting of three e-commerce pilot projects. "Pet Licenses Online" is one of these pilot projects. In 2003, an e-commerce pilot will begin that allows the public to purchase or renew pet licenses over the Internet using their credit cards to complete the transaction.
- Community Locations. King County has coordinated with over 120 partners
   (Attachment 2) including city halls, veterinary clinics, licensing agencies, community
   service centers and other businesses and groups to sell pet licenses throughout the
   suburban and rural areas of the county. Pet owners can easily take advantage of
   locations in their own communities and neighborhoods. A list of sites and partners is
   included on the County's website.
- Mail. Pet owners can purchase and renew pet licenses through the mail. Renewal forms are currently automatically sent out through the mail, and additional pets can be added and licensed at the time other pet licenses are being renewed. Applications for new licenses can be picked up at many community locations, downloaded from the Internet or can be mailed out upon request. A promotional pet-licensing flyer, produced in collaboration with Seattle Animal Control, has been included in every vehicle registration renewal mailing sent out from the County's Licensing Section offices for approximately three years (Attachment 4). Also, the County provides special mailings from time to time (Attachment 5), promoting pet licenses and encouraging pet owners to purchase licenses. Pet license applications have also been included with "Val Pak" coupon mailings. Although the response rate to mailings is usually low (common to mailed sales campaigns), there is the educational value of reminding pet owners of the licensing.

Despite the presence of a wide variety of convenient options and the implementation of various mail and media campaigns to license pets, many pet owners who are busy, unaware, or who have not been able to complete the pet license process are best served by personal outreach, and the field canvassing program effectively serves these individuals.

Although residences in rural areas are not densely arranged, they can be efficiently served by the field canvassing door-to-door service. Field canvassers have been trained to recognize and appreciate the unique characteristics of rural communities. The presence of field canvassers is often a positive opportunity to demonstrate that residents of rural areas deserve the same services as other County residents, and allows canvassers to provide educational materials, answer questions about the program, and safeguard rural pets with license protection. Pets in rural communities get loose and lost, as in other areas, and when they are licensed, they can be promptly reunited with their families.

The field canvassing program in rural areas has been reviewed by the Records, Elections

and Licensing Services Division, and it is concluded that the program is being conducted efficiently and appropriately.

### 9. REVENUES AND EXPENDITURES

The revenues and expenditures for the field canvassing program are as follows:

In addition to the revenue projections listed above, the field canvassing program is also largely responsible for approximately \$500,000 in indirect license renewals on an annual basis. The pet license canvassing effort is essentially the primary marketing tool King County uses to increase the number of pets licensed on an annual basis. It is the canvassing program that generates nearly all of the new growth in overall sales from one year to the next.

In the 10 years since the canvass program began, pet license sales have increased 70%:

### 10. PLANNED CUSTOMER SERVICE IMPROVEMENTS

The Division will be implementing two major customer service improvements for 2003. First, an e-commerce pilot has been approved to allow for the purchase and renewal of

pet licenses via the Internet. Second, funding was approved to build an isolation room at the Kent Shelter that will provide for increased health of sheltered animals. In addition, efforts will continue in the area of staff cross-training, meeting pet license sales goals, and improved information on the Web site.

### 11. SUMMARY

Many county residents have been well served by the field canvassing program. It is our experience that pet owners appreciate the convenience of our field canvassing service. It has successfully and significantly helped protect many more dogs and cats in the community through pet identification.

The Pet Partnership Program received a coveted Achievement Award in 2001 from the National Association of Counties (Attachment 5) "in recognition of an innovative program which contributes to and enhances county government in the United States." Our certificate is signed by Councilmember Jane Hague (NACO President).

The Pet Partnership Program is a pioneering program intended to make King County's regional animal control services financially self-supporting by increasing pet license revenue while simultaneously promoting responsible pet ownership. The program marks an unprecedented level of intergovernmental cooperation with 32 suburban cities within the County in collaboratively promoting and selling pet licenses as a way to avoid special assessments or service reductions. In addition, partnerships have also been forged with veterinary clinics, private sector businesses and a variety of non-profit community groups to promote and sell pet licenses (Attachment 2).

Many jurisdictions across the United States consider King County a trail-breaking model for pet licensing. Animal Services and Programs Section staff frequently receive calls from other animal control agencies seeking information and advice to enable them to use our program as a benchmark. The positive achievements hailed by other jurisdictions are: the enhanced protections by licensing more animals, the assistance provided to animal control enforcement efforts through the identification of greater number of animals, and the revenues generated by the licensing efforts.

Pet licensing and canvassing services have been modified over time, as more productive and efficient methods are determined, and as customer and public feedback have suggested. The Animal Services and Programs Section remains committed to the programs goals and is open to further feedback to assure services are provided in the most efficient and appropriate means.

- Pets must be listed on the enclosed renewal.
- \*If you renew by the 10th of next month (the month when the license expires) you are eligible for this great offer!
  - 1. Your renewal must be postmarked by the 10th of the month when the license expires. If you renew the license over the counter at any of our license sales locations, the renewal must be made and paid for by the 10th of the month when the license expires.
  - 2. You need to write on your renewal form: MICROCHIP VOUCHER.
  - 3. We will mail you a voucher (coupon) with your new license tag. Or, if you renew over the counter, the sales agent will provide you with your voucher.
  - 4. Instructions for having the microchip implanted (at the Animal Control clinic) in your pet will be included with the voucher.

### Additional information about new benefits

### (1) About Microchips

A microchip is the size of a grain of rice. These tiny electronic chips are safe. and they increase the chances of finding the family of a lost pet, especially if the pet's license identification has fallen off. The chips are designed to stay just under the skin where the veterinarian implants them.

A microchip does NOT replace the need for a pet license; it is good back up identification. The visible license tag hanging on your pet's collar is the best identification and protection.

A small handheld scanner - like the ones used at store checkout counters can read the identification information in the chip. The microchips do not have batteries, or any other kind of internal power source for that matter, so you never need to replace parts. Using a radio signal, the scanner can read the information on the chip in less than a second.

The chip's electronic code corresponds to your contact information in your pet's King County pet license record. Your contact information can be updated in the King County pet license database if you move or change phone numbers (the chip does not have to be touched).

### Attachment 5.56 Succribing to Pet News

If you are the owner of a dog or cat licensed with King County and would like periodic e-mail news about pets, pet care, animal behavior, and other topics of interest, please subscribe to PET NEWS, the County's new online pet information service. You will receive quarterly (or as news develops) emails with articles and seasonal features about issues affecting pets and pet owners. This is another great benefit of having your pet licensed with King County—there is no additional charge for this service.

### Other benefits of a King County pet license

### If your pet gets lost

Pet adoptions

You are called immediately when your pet is found and is brought to the shelter. Or if a neighbor finds your pet, they can call you directly through the Found Pet Information Line, (206) 296-PETS

Your pet gets a Free Ride Home if your licensed pet is found. County staff will even attempt to drive your pet right back home to you, instead of being brought to the Animal Shelter.

Your pet gets a Longer Care Period. When found, your licensed pet will be safely sheltered at the county Animal Shelter for a longer time, while we try to contact you.

When you go out of town, just call us at (206) 296-2712 to say where your pet will be while you are out of town, and/or who will be taking care of your pet and where to reach you. We can then call the correct number or person if your pet should get loose while you are out of town.

County and city laws require licenses for dogs and cats. By licensing your pet, you will be in compliance with these beneficial laws.

### ② Did you know?

Your pet license fees help save thousands of animals' lives. In addition to the valuable services described above, pet license revenues benefit the entire community by helping to provide a range of additional programs such as spay/neuter services to control pet over-population, investigation into animal neglect, and finding new families for homeless animals. Pet license revenues also save County taxpayer dollars by reducing the general fund subsidy to our excellent regional animal program.


