15 On page 14, strike everything on line 308, and insert:

16 "Community services operating \$3,006,080"

18 On page 18, on line 387, after "2016," strike \$2,986,080 and insert: "\$(~~2,986,080~~)

22 "Gender Justice League _____ \$10,000"

24 On page 20, strike everything on line 426, and insert:

25 "Northwest Immigrant Rights Project ((~~\$25,897~~) \$35,897"

27 Renumber the remaining sections consecutively and correct any internal references
28 accordingly.
