Written public testimony will be accepted from 9 a.m. on November 1, 2024 through 10 a.m. on December 3, 2024, by sending such public festimony to clerk.council@kingcounty.gov. It is expected that the Council will take action on this Proposed Ordinance at the December 3, 2024 meeting following the public hearing.

The Proposed Ordinance would modify the County's permit review process in multiple ways, including preapplication conference requirements, application submittal and screening requirements, notice of application, and timelines for final decisions.
