NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Monday, June 1, 2015, beginning at 1:30 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2015-0169 (Ordinance 18059) an ordinance renewing for six-months an existing moratorium on the establishment or location of medical marijuana dispensaries and collective gardens.

### SUMMARY:

Ordinance 18059 renews for six-months an existing moratorium on the establishment or location of medical marijuana dispensaries and collective gardens asserted to be or actually authorized under Chapter 181, Laws of Washington 2011, and chapter 69.51A RCW.
