NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council on the 7th day of June, 2022, at 1:00 p.m. to consider adoption of Proposed Ordinance 2022-0172, which establishes the sewer rate and capacity charge for the year 2023. The public hearing is planned to be held at the King County Courthouse, 516 3rd Ave, Room 1001, Seattle, Washington; and/or the hearing may be held remotely on Zoom. Information on the public hearing and how to submit public testimony can be found at this website: https://kingcounty.gov/council/committees/full_council.aspx. It is expected that the full Council will take action on this Proposed Ordinance at the June 7, 2022, meeting following the public hearing.

SUMMARY
King County is proposing Ordinance
2022-0172 to:

• Make a determination of the sewer rate for the year 2023 that must be charged in order to meet the monetary requirements (administration, operating, and maintenance, repair and replacement costs) of the County's sewage disposal program. The proposed sewer rate for 2023 is \$52.11 per month per residential customer equivalent (RCE). By comparison, the sewer rate for the year 2022 is \$49.27 per RCE per month.

• Set the capacity charge for sewer connections occurring between and including January 1, 2023, and December 31, 2023. The capacity charge is the fee that is assessed against customers establishing new connections to ensure that those customers bear their equitable share of the cost of new capacity-related sewage facilities necessary to serve them. The proposed capacity charge is \$72.50 per month per RCE for fifteen years. By comparison, the capacity charge for the year 2022 is \$70.39 per RCE per month for fifteen years.
