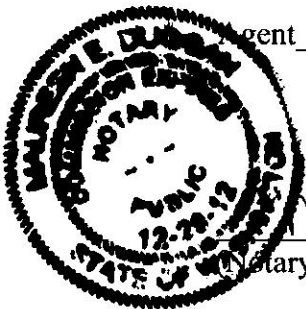

Metropolitan King County Council (the
Council) held a public hearing in the Council
Chambers on the 10th Floor of the King
County Courthouse (516 Third Avenue, Seattle,
WA) on Monday, November 26, 2012,
beginning at 1:30 PM. The purpose of this
public hearing was to consider adoption of
Proposed Ordinance (PO) 2012-0103 (Ordinance
17485) relating to comprehensive
planning and permitting. Ordinance 17485
was adopted on December 3, 2012.

SUMMARY:
Proposed updates to the KCCP were transmitted by the King County Executive on March 1, 2012 and reviewed by the Transportation, Economy and Environment Committee. The 2012 Comprehensive Plan Review Committee made its recommendation on September 19, 2012 and the Committee of the Whole made its recommendation on October 8, 2012. Council action took place on December 3, 2012.
