NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington, on the 25th day of June, 2018, at 1:30 p.m., to consider adoption of Proposed Substitute Ordinance 2018-0161, (Title 14 Updates)

SUMMARY

Proposed Substitute Ordinance 2018-0161 amends and recodifies certain chapters of the King County Code Title 46 Traffic Code under King County Code Title 14. Proposed changes to the code as set forth in the proposed ordinance include:

- Providing a process by which a member of the public may formally request a speed limit study;
- Providing for appeal of speed limit revisions to the hearing examiner for recommendation to Council; and
- Granting authority to the traffic engineer to place signage restricting stopping, standing or parking of vehicles in places exceeding 100 feet in length;
