1 AN ORDINANCE authorizing the King County executive
2 to execute an amendment to the interlocal agreement with
3 the King County flood control zone district extending the
4 duration of the interlocal agreement through December 31,
5 2013.

6 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

7 **SECTION 1. Findings:**

8 A. On February 17, 2009, King County and the King County flood control zone
9 district entered into an interlocal agreement ("ILA"), as authorized by King County
10 Ordinance 16341 and district Resolution FCD2008-17.1, whereby the county as service
11 provider to the district would provide flood protection services and implement the
12 district's annual work program and budget. The ILA originally had a termination date of
13 December 31, 2010.

14 B. Section 13.1 of the ILA was amended in 2010 to allow the district to extend
15 the term of the ILA once for two years by sending notice to the county of its intention to
16 extend the ILA on or before December 31, 2010. Such a notice was provided to the
17 county in a timely manner and so the current termination date of the ILA is December 31,
18 2012.

19 C. The county and the district agree that Section 13.1 of the ILA should be
20 further amended to extend the term of the ILA through December 31, 2013.

21 D. The county and the district agree that a new section should be added to the
22 ILA, addressing the timing of county notice to the district in the event that the county
23 absorbs the functions of the district, as may be authorized by proposed state legislation.

24 E. The county and the district agree that sections 7, 10.1 and 10.2 of the ILA
25 should be amended to provide for more efficient procedures and to clarify the respective
26 roles and responsibilities of the county and district.

27 F. The third amendment to ILA, Attachment A to this ordinance, amends the ILA
28 to effectuate the agreed upon terms provided for in subsections C., D. and E. of this
29 section.

30 SECTION 2. The county executive is hereby authorized to execute an

31 amendment to the ILA substantially in the form of Attachment A to this ordinance. All
32 other provisions of the ILA shall remain in full force and effect.


