METROPOLITAN KING COUNTY COUNCIL NOTICE OF ADOPTION

Ordinance 18861

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Monday, January 14, 2019, beginning at 1:30 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2018-0559 (Ordinance 18861) adopting amendments to the King County Code to create a definition for transit comfort facilities and to add the use to the permitted uses table.

SUMMARY:

The proposed legislation was transmitted by the King County Executive on November 5, 2018. The updates were reviewed by the Planning, Rural Service and Environment Committee, which adopted amendments and made its recommendation on December 4, 2018. Council action took place on January 14, 2019.
