**PARKING VIOLATION
PAYMENT INSTRUCTIONS**

This parking violation notice represents a determination that an infraction of King County Code 7.08.050 has been committed. A civil penalty has been assessed. This determination will be final unless you contest it in writing within ten (10) days of issuance (instructions below).

If not contesting, you must respond within 30 days. Failure to do so will result in additional monetary penalties and referral to a collection agency. It may also result in 1) tow and impound of the vehicle 2) loss of park or recreation facility use privileges. A vehicle with 3 or more unpaid parking infractions may be towed and impounded without notice. See KCC Ch. 7.30; KCC Ch.46.08.

All mailed responses must be postmarked by midnight on the day the response is due.

To Locate the Scheduling Office, from the West Lake Sammamish Pkwy entrance to Marymoor, go to the first stop sign and turn right. The Scheduling/ Maintenance building is on your immediate left. Go to the far end of the building to locate the Scheduling Office door with envelopes and drop slot.

PURCHASE A 12-MONTH PARKING PERMIT FOR \$110 WITHIN 30 DAYS.

The fine will be reduced to \$10 and a 12-month (\$100 value) parking permit will be mailed within three working days of receipt by King County Parks.

2. I REQUEST A DIRECTOR'S REVIEW AND HAVE ENCLOSED WRITTEN INFORMATION DESCRIBING CIRCUMSTANCES TO JUSTIFY RECONSIDERATION. You may appeal the Director's review to the King County Hearing Examiner. See KCC Ch. 7.30, KCC Ch. 20.24
