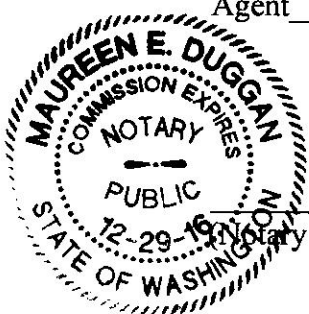

### METROPOLITAN KING COUNTY COUNCIL NOTICE OF HEARING ON FRANCHISE APPLICATION OF EDGEHILL WATER ASSOCIATION

#### Proposed Ordinance 2014-0218

NOTICE IS HEREBY GIVEN that an application has been filed with the Metropolitan King County Council by the EDGEHILL WATER ASSOCIATION to renew its franchise in council district three and that a public hearing will be held upon said application before the Metropolitan King County Council in Room 1001, King County Courthouse, Seattle, Washington, on the 28th day of July, 2014 at 1:30 P.M. The purpose of this public hearing is to consider adoption of Proposed Ordinance 2014-0218, to approve a proposed new franchise for the EDGEHILL WATER ASSOCIATION and to authorize the King County executive to execute the new franchise agreement. The following is a legal description of the area:

Lying within the South ½ of Section 19, Township 24 North, Range 6 East, W.M.; Beginning at a point on the South line of said Section 690.86 feet West of the Southeast corner of said Section, ALSO said point is the East margin of the Plat of Edgehill Addition, in Volume 75 of Plats, pages 94-96, records of King County; Thence Northerly along the East margin of the Plat of Edgehill Addition to the Northeast corner of said plat; Thence West 1,075 feet; Thence North 240 feet; Thence West 190 feet; Thence North 400 feet; Thence West 280 feet, more or less; Thence North 690 feet, more or less, to a point on the North line of the South ½ of said Section, which is 645.90 feet East of the North-South centerline of said Section; Thence West 984.41 feet; Thence South 675 feet; Thence West 340 feet; Thence South 161.43 feet; Thence East 340 feet; Thence South 161.19 feet; Thence West 170.52 feet; Thence South 292.62 feet to a point on the North margin of SE 60th St.; Thence Southeasterly to a point on the centerline of SE 60th St., which is 467 feet, more or less, West of the North-South centerline of said Section; Thence South to the South line of said Section; Thence East along the South line of said Section to the point of beginning.
