10 number of appeals filed in the preceding year, and

11 WHEREAS, convening of the board is necessary to resolve all 2020 appeals;

To Chair Balducci:

For the 2020 assessment year, 4,260 appeals have been filed to-date which exceeds ten percent of the 4,940 appeals filed for the 2019 assessment year. As a result, the statutory requirements for convening under Revised Code of Washington (RCW) 84.48.010(4) have been satisfied and the county Board of Appeals & Equalization (“the Board”) respectfully requests the county legislative authority’s approval to convene in order to resolve all 2020 assessment year appeals.

RCW 84.48.010(4) states,

“...the county board of equalization with the approval of the county legislative authority may convene at any time when petitions filed exceed twenty-five, or ten percent of the number of appeals filed in the preceding year, whichever is greater.”


