1           A MOTION concerning the regional policy committee  
2           review of the 2019 Comprehensive Solid Waste  
3           Management Plan.

4           WHEREAS, the King County Charter establishes regional committees to develop,  
5           recommend and review regional policies and plans for consideration by the metropolitan  
6           King County council, one of which is the regional policy committee, and

7           WHEREAS, the 2018 regional policy work committee program identifies the  
8           comprehensive solid waste management plan as within the subject matter area for the  
9           committee, and

10          WHEREAS, the charter and K.C.C. 1.24.065 establish a one-hundred-twenty day  
11          timeframe for the regional policy committee to review legislation referred to it by the  
12          county council. However, the committee may request, and the county council may grant  
13          by motion, additional time for review, and

14          WHEREAS, the ordinance adopting the 2019 Comprehensive Solid Waste  
15          Management Plan was introduced on July 30, 2018, and the charter- and code-mandated  
16          timeline would require review and action by November 27, 2018, and

17          WHEREAS, the regional policy committee staff does not have the capacity during  
18          the council's budget deliberation process to support the committee's review of the 2019  
19          Comprehensive Solid Waste Management Plan, it is the regional policy committee chair's

20 desire to allow for additional time for review of the 2019 Comprehensive Solid Waste  
21 Management Plan, and

22 WHEREAS, the regional policy committee and the council are committed to  
23 effective and efficient legislative review processes that respect the charter and code  
24 mandated legislative process for the review of countywide plans and policies, and

25 WHEREAS, the regional policy committee concurred with the Chair's  
26 recommendation to introduce this motion requesting the King County council to extend  
27 the one-hundred twenty day timeframe to allow the regional policy committee until  
28 March 31, 2019 to review and act upon the 2019 Comprehensive Solid Waste  
29 Management Plan;

30 NOW, THEREFORE, BE IT MOVED by the Council of King County:

31           The regional policy committee shall have until March 31, 2019, to review and act  
32 upon the 2019 Comprehensive Solid Waste Management Plan.


