Earlier this year, the 2025 Washington State Legislature passed Engrossed Substitute Senate Bill (ESSB) 5814, which added new business activities to the definition of retail sales. As a result, Seattle Times Media Solutions will be required to begin collecting sales tax on Advertising services listed below starting Oct. 1, 2025.

Note that all advertising in Seattle Times products, including promotion related to Branded Content, is exempt from sales tax, per RCW 82.04.214.

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing on Tuesday, October 7, 2025, beginning at 1:30 PM to consider adoption of Proposed Ordinance 2025-0268 (Ordinance 19980), an ordinance modifying the County's allowances for doctor's office/outpatient clinic uses in the Residential zones. The Council adopted this Ordinance at the Tuesday, October 7, 2025, meeting.

SUMMARY:
The Ordinance modifies the allowance for the "doctor's office/outpatient clinic" use to the permitted use table. It allows doctor's office/outpatient clinic uses as a Permitted use outside of the urban area, only in the R-24 and R-48 zones, as a reuse of surplus non-residential facility, and where it is served by public sewer. It also exempts this allowance from the requirements in K.C.C. 21A.12.250 that otherwise would add limitations on the location of doctor's office/outpatient clinic uses and impose on-site parking maximums.





NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing on Tuesday, November 18, 2025 beginning at 11:00 AM to consider adoption of Proposed Ordinance 2025-0320 (Ordinance 20016), an ordinance adopting the capital facilities plans of the Auburn, Enumclaw, Federal Way, Fife, Highline, Issaquah, Kent, Northshore, Lake Washington, Renton, Riverview, Snoqualmie Valley and Tahoma School Districts, and adopting school impact fees for these districts. The Council adopted this Ordinance at the Tuesday, November 18, 2025, meeting.

SUMMARY:

King County administers school impact fees on behalf of each school district that participates, by collecting fees from residential developers. The fees are developed by the individual school districts in accordance with provisions in state law and the King County Code, and are set forth in the districts' capital facilities plans.

Ordinance 20016 amends Title 20 to update the school capital facilities plans and Title 27 to implement the collection of impact fees by the county on behalf of the following school districts, effective January 1, 2026:



Ordinance 20024**

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing on Tuesday, December 2, 2025 at 1:30 PM to consider adoption of Proposed Ordinance 2024-0408 (Ordinances 20024), which adopts the Critical Area Ordinance and 2025 Comprehensive Plan. The Council adopted this Ordinance on the same day.

SUMMARY:

King County is required to designate critical areas and adopt development regulations to protect critical areas as part of the comprehensive plan review and evaluation required by the Growth Management Act. Review and updates to critical area policies and regulations include provisions to protect public health and safety by limiting development in hazard areas, such as steep slopes and channel migration zones, and to protect environmentally critical areas, including wetlands and aquatic areas.

King County Comprehensive Plan policies and development regulations in King County Code that protect critical areas are often referred to as the Critical Areas Ordinance. The Critical Area Ordinance is developed based on best available science (BAS). Under the substantial progress exception in RCW 36.70A.130(7)(a), the county is required to take action no later than December 31, 2025 to complete the associated updates to critical areas regulations.
