 16          administration committee appoints members to the citizens' elections oversight  
 17          committee, and

18          WHEREAS, in accordance with K.C.C. 2.53.021, appointments to the citizens'  
 19          elections oversight committee are subject to confirmation by the full council by motion,

21 WHEREAS, on August 23, 2022, in accordance with K.C.C. 2.53.021, the  
22 employment and administration committee appointed Jude Ahmed to the citizens'  
23 elections oversight committee, for a three-year term to expire on September 30, 2025;

25 The appointment of Jude Ahmed to the citizens' elections oversight committee as  
26 the representative from a nonpartisan organization in King County that promotes equality  
27 and the advancement of blacks or African Americans, for a three-year term to expire on  
28 September 30, 2025, is confirmed.


