


King Conservation District is a nonregulatory, special purpose district, funded by rates and charges, with a mission to promote the sustainable use of natural resources through voluntary stewardship in King County.

We provide education, technical assistance, and cost-sharing to private residents in forest management, farm conservation planning, wildfire preparedness, and streamside and shoreline enhancement.

We also provide grants, and work with cities and other organizations to support community gardens, urban forest canopy, and local food systems.

Forestry

 71% of respondents reported improvement to their forest after working with KCD.

Farm

- 83% of respondents said they implemented a practice recommended in their farm conservation plan.
- 77% reported improvements to their farm one year out.

KCD Cooperatoriparian

Outcomes 2021-2024

- 89% of respondents reported improvements to their property.
- 81% of respondents said they were unlikely or very unlikely to implement a streamside restoration project on their own.
- 84% likely or very likely to recommend service to a neighbor

CommuniTreeSupport (District 1)

- City of Shoreline annual tree giveaway/planting program
- KCD Forestry staff provided site visits, recommendations, and installation
- 170 site visits provided
- 243 trees given to 169 participants

Contaminant Soil Test for Community Gardens (District 2)

- 64 free soil tests to 11 higher risk urban gardens
- Tested for lead and arsenic
- Held 3 workshops educating 75 International Rescue Committee gardeners and staff about safe soil





Business Impact NW (District 3)

- Supported by KCD Regional Food System Funding
- Provides training, technical assistance, one-on-one coaching, and food production space to growers
- Aash Farms in Woodinville was able to expand their no-till, regenerative farm and launch value-added products
- 762 hours of coaching and training to 233 clients in 2024





Wolf Creek Ravine Urban Forest Management Plan (District 4)

- Developed forest management plan with community input
- 20 actively participating households
- Currently drafting scope of work





3rd Annual Tukwila Tree Giveaway (District 5)

- 285 trees distributed
- 663 trees since 2022





Big Soos Creek Riparian Restoration (District 5)

- 500 ft streamside
- 1.25 acre riparian area enhanced
- Supports spawning migration of Chinook, pink, coho, chum, and sockeye salmon







Eastside Prep Studented Campus Restoration (District 6)

- 430 Native Trees and Shrubs Planted
- Led by school's Green Club
- Restores riparian area along salmon-bearing Cochran Springs Creek









Green Kent Urban Natural Resource Management Program Phase 2 (District 7)

- KCD Member Jurisdiction Grant funded
- Previous funds assisted with natural areas and urban forest assessments
- 2024 Funds support increased site management, environmental education, and community engagement at Green Kent sites





Restaurant 2 Garden (District 8)

- Chinatown International District community-driven project
- Diverts restaurant food waste to community gardens









Cover Crop Support (District 9)

- 553 Acres of cover crops across King County funded
- Supports farm resilience and regenerative farming
- Peer-to-peer tours educated farmers new to the practice
