Councilmember Phillips reported on the Sound Transit Board meeting. He indicated that CEO Joni Earl presented the 2013 proposed budget. Highlights of the budget included continued construction of the ST2 expansion, University Link Light Rail, design and construction of the South 200 extension, the final design of Northgate link and eastlink light rail and work on Mukilteo and Tukwila Sounder stations. Sound Transit expects to deliver 28.4 million passenger trips in 2013. The Board also heard an update from the Citizen's Oversight Panel with suggestions for growing. The Board authorized a contract to design and construct the South 200 Link Light Rail extension.

Councilmember von Reichbauer reported on a successful community fundraiser for homelessness programs in South King County.

Councilmember Dunn reported on the press conference held by the King County Flood Control District Board of Supervisors. October is Flood Awareness Month and the District is making efforts to educate the public on emergency preparedness and the upcoming flood season.
