Inspect and permit farmer's markets and other temporary food events




Inspect and permit restaurants, and issue safety rating for the public








EHS Funding Sources*

Food Safety Program

Permits:


- 12,000+ permanent food establishments (restaurants, food trucks, grocery stores, etc.)
- 2,500+ temporary food events (fairs, festivals, conventions)
- 350+ farmers market vendors
- Each year:
 - Conducts 20,000+ routine/educational inspections
 - Responds to 1,000+ complaints
 - Review and approve 900+ new food businesses





On-site Sewage Permitting and Operation and Maintenance Programs

- Annually review 1,200+ on-site sewage system designs and permit installations for new development, replacing failing septic systems, and building permits
- Annually review 2,500+ time of sale on-site sewage system inspections
- Certify 150+ industry professionals to work in King County
- Respond to 150 complaints each year, working with property owners to ensure that failing on-site sewage systems are corrected





Relationship between BOH and EHS

BOH advocates for the preservation, promotion, and protection of public health

 EHS focuses on disease prevention and on preventing and reducing environmental pollution to protect health

BOH defines and mandates regulations

- EHS implements BOH code mandated services
- Regulations include permit types, renewal schedules, exemptions, etc.

BOH authorizes fees

- Services provided in a full cost recovery model
- Fees are based on rates
- EHS issues permits and charges fees to provide services



What are Rates and Fees?





Why is EHS doing a rate study?

- Per BOH Code 2.06.008, EHS is required to conduct a rate study at least every five years.
- Last rate study was conducted in 2019.
- Per King County policy, **EHS is required to cover all the costs of its regulatory programs through permit fees.** This includes labor, rent, equipment, supplies and all other costs of doing business. State law ensures the fees are not more than the cost of providing the service (RCW 70.05.060 (7)).



Project Plan/Phases of Rate Study

Work Plan and Schedule

- Data gathering
- Time & effort study
- Review and validation of demand forecasts and forecast model
- Customer feedback survey

Analysis

- Financial modeling
- Equity considerations
- Rate comparison with other jurisdictions
- Finalize rate model

Rate Study Report

- Compilation of final report
- BOH final briefing and Rule & Regulation
- If approved, fee schedule implemented Jan. 2025
