Dear Councilmember Balducci:

As required by Ordinance 19210, Section 92, Proviso P2, this letter transmits certification that King County has worked in collaboration with the City of Maple Valley to facilitate the IRONMAN 70.3 Washington competition to be held on September 19, 2021.

Parks and Recreation Division (Parks) of the Department of Natural Resources and Parks (DNRP), the Facilities Management Division (FMD) of the Department of Executive Services, and the Road Services Division of the Department of Local Services (DLS) with the City of Maple Valley met with City representatives to streamline permitting and use of County facilities. The attached certification provides details on meetings, correspondence, and actions taken, as well as the status of permits and fee waivers associated with the competition.

This Proviso response furthers the King County Strategic Plan goal of efficient, accountable regional and local government and its objective to deliver consistent, responsive, equitable, high-quality services to residents, cities, and districts.

It is estimated that the work to complete the certification required 25 hours by County to produce, costing approximately \$3,500.

The work discussed in the certification document will allow King County to assist the City of Maple Valley as it hosts this important recreational event which King County residents will have the opportunity to attend.


