6 STATEMENT OF FACTS:

- 7 1. The Lake Washington School District desires to provide school
8 resource officer services during the 2006-2007 school year at nine
9 different junior high and elementary schools in the district.
10 2. The county has the ability to provide those policing services.
11 3. Participation in this agreement is to the benefit of the citizens of King
12 County.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. The county executive is authorized to execute an agreement,

15 substantially in the form attached to this ordinance, with the Lake Washington School
16 District to provide law enforcement and policing services.



**Amendment to Agreement
Between King County and the Lake Washington School District #414
Relating to Law Enforcement Services**

WHEREAS King County, a home rule charter county and a political subdivision of the State of Washington, hereinafter referred to as the "County," and the Washington State School District #414 (Lake Washington School District), hereinafter referred to as the "School District" have an agreement relating to law enforcement services,

NOW THEREFORE, the County and School District hereby agree to the following amendments:

1. **Section 1.1 is amended to read: Security Services.** The County will provide as a supplementary service part-time, off-duty, commissioned deputies dedicated to the security needs of the District. The officer will provide law enforcement services to the district, as detailed in Attachment A to this document, incorporated hereto. Such services shall include patrol of District grounds, preparation of daily reports as needed, providing resources for students and staff, and other duties as mutually agreed upon by the parties.
2. **Section 3.1.3 is amended to read:** All liabilities for salaries, wages, any other compensation, injury, or sickness arising from performance of the law enforcement services by the County hereunder shall be that of the County.
3. **Section 4.1 is amended to read:** The estimated contract amount for 2006-2007 is \$32,000. Such compensation includes selected deputies at their current overtime rate. The amount of the contract shall be revised each year in which services are purchased by the School District via a revised Attachment A.
4. **Section 4.3 is amended to read:** The County will bill the school district for the hours worked at the actual overtime rate for each deputy, including applicable benefits. Payments are due within 30 days after invoicing by the County.
5. **Section 4.4 is removed.**
6. **Section 4.5 is renumbered as Section 4.4 and amended to read: Other.** For the County's budget planning purposes, the School District will transmit to the County on or about June 1 the estimated amount of supplemental services, if any, which the School District wishes to purchase.
7. **Section 7.3 is amended to read:** The School District shall indemnify and hold harmless the County and its officers, agents and employees, or any of them, from any and all claims, actions, suits, liability, loss, costs, expenses and damages of any nature whatsoever, by reason of or arising out of any act or omission of the School District, its officers, agents and employees or any of them, relating to or arising out of the performance of this Agreement. In

the event that any suit based on such a claim, action, loss or damage is brought against the, County, the School District shall defend the same at its sole costs and expense; provided that the County retains the right to participate in said suit if any principle of governmental law is at issue; and if final judgment be rendered against the County and the School District and their respective officers, agents and employees, or any of them, the school District shall satisfy the same.

- 8. **Attachment A is removed. Attachment B is renamed Attachment A and is amended as shown in the attachment to this amendment.**

**Attachment A to Agreement
Between King County and the Lake Washington School District #414
Relating to Law Enforcement Services**

A part-time officer will work with each of the following schools to identify the specific needs of students and the appropriate services that will be provided by the School Resource Officer.

- Evergreen Junior High
- Finn Hill Junior High
- Kamiakin Junior High

In addition, when requested by the principal or district administration and agreed to by precinct command staff, these officers will be available for service at the following elementary schools:

- Thoreau Elementary
- Sandburg Elementary
- Muir Elementary
- Keller Elementary
- Frost Elementary
- Wilder Elementary

Services include the following:

1. Staff training on topics such as youth gangs, violence intervention, drug identification and intervention.
2. Student education: Assist in classroom instruction by discussing topics such as substance abuse prevention, criminal and constitutional law, and personal protection.
3. Parent education on topics such as emerging youth issues related to violence, substance abuse and the criminal justice system.
4. Building rapport with students to help students to see officers as a youth advocate whose primary concern is their safety and security.
5. Law Enforcement/Safety Assistance to Schools:
 - a. Assisting with issues such as truancy, child abuse, suicide and violence.
 - b. Providing site security and law enforcement services on an as-needed basis.
 - c. Help staff to develop a site security plan.

King County will be allocated \$32,000 for the 2006-2007 school year.
