NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington, on Tuesday, the 29th day of May, 2018, at 1:30 p.m., to consider adoption of Proposed Ordinance 2017-0244, which would amend the King County Code to modify the shoreline development code. Substantive changes include clarifications to definitions, permitted alterations to critical areas, alteration exceptions to critical areas/setbacks from critical areas, permitted shoreline modifications, docks and other similar structures, shoreline permit requirements, shoreline nonconformances, procedural requirements and shoreline master program elements.
