

<p>NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington, on the 9th day of December, 2013, at 1:30 p.m., to consider adoption of Proposed Ordinance 2013-0455, authorizing the King County executive to enter into an intergovernmental land transfer agreement between King County and the Washington State Department of Natural Resources for transfer to the State of the 28.22-acre Little Si Natural Area located at the southwest corner of the Mount Si Natural Resource Conservation Area.</p>
SUMMARY
<p>The King County executive has concluded discussions with the Washington State Department of Natural Resources regarding the transfer of the Little Si Natural Area, which is 28.22 acres in size and located just east of the City of North Bend on the western boundary of Mount Si Natural Resources Conservation Area (NRCA), which is managed by the Washington State Department of Natural Resources. Little Si Natural Area borders the Mount Si NRCA on its north and eastern boundaries, the Middle Fork of the Snoqualmie River on its western boundary and private property on its southern boundary. It is located approximately 1 mile north of Tanner Landing Park and approximately 400 feet east of the northern end of 434th Avenue SE.</p> <p>Once the transfer agreement is approved and executed, the site will be managed by the Washington State Department of Natural Resources and will remain open and available for public use.</p> <p>The transfer agreement provides for King County to transfer ownership of the site within 30 days following execution of the agreement by both parties.</p> <p>A copy of Proposed Ordinance 2013-0455 will be mailed upon request to the Clerk of the Council, Room 1200, King County Courthouse, 516 Third Avenue, Seattle, WA 98104, telephone 206-477-1020.
