28 NEW SECTION 2. There is hereby added to K.C.C. chapter 14.16 a new section
29 to read as follows:


30 **Wagners Bridge 364-B.** The use of Wagners Bridge 364-B shall be prohibited to

31 loads in excess of seven tons for three axle vehicles, ten tons for five axle vehicles, and
32 twelve tons for six axle vehicles until further notice.




