# Methodology for long-term capital improvement needs

#### **Work Order Task Scope**

- Assessment of WTD's current capital forecasting methodologies
- Identify 3 to 4 alternative methods, analyze pros and cons, and develop a recommended methodology
- Produce template for longterm capital forecast

#### Requirements

- Use Portfolio
   Management categories
- Accommodate multiple time horizons (20, 50, 75 years)
- Allow for scenario testing with different assumptions
- Clear and understandable

# Methodology for long-term financial forecast

#### **Work Order Task Scope**

- Document the assumptions (aka variables) that affect WTD financial forecast
- Identify refined or alternative variables, evaluate and make recommendations
- Develop sensitivity analyses to illustrate effects of different variables
- Create standard templates for use in future forecasts

#### Requirements

- Accommodate multiple time horizons (20, 50, 75 years)
- Provide observations and insights as to how forecasts can inform decision-making
- Clear and understandable
