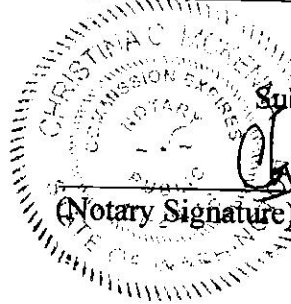

NOTICE IS HEREBY GIVEN that a proposed ordinance for the vacation of a portion of Geo Bayne Road & Alex McKinnon Road has been filed with the Clerk of the County Council.

A public hearing will be held before the King County Hearing Examiner, on the Twelfth Floor - in the Gieger Conference Room, of the King County Courthouse, 516 - 3rd Avenue, Seattle, WA 98104 on the 9th of December, 2015 at 10:00am or soon thereafter.

NOTE: If the Seattle School District announces a district-wide school closure due to adverse weather conditions or similar area emergency, the public hearing on this matter will be postponed. Parties of record will be notified of the time and date of the rescheduled hearing. Questions can be directed to the Hearing Examiner's Office at (206) 296-4660.

The area to be vacated is described as follows: A portion of the Geo Bayne Road also known as County Road No.1224 rights-of-way (ROW) and a portion of the Alex McKinnon Road also known as County Road No.381 ROW. The area is lying about one-quarter of a mile north of the Kanaskot Palmer State Park, in the northeast quarter of Section 10, Township 21 North, Range 6 East, Willamette Meridian, King County, Washington. The ROWs are located adjacent to the following properties: Parcel numbers 1021079158 and 1021079081. Containing an area of 10,337 square feet, more or less. The adjacent parcels are zoned RA-5.
