1 AN ORDINANCE relating to taxicab and for-hire vehicles,
2 increasing fees; and amending Ordinance 13334, Section 2,
3 as amended, and K.C.C. 6.64.025.

6 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

7 SECTION 1. A. Section 2 of this ordinance proposes changes to existing taxicab
8 and for-hire vehicle fees and for-hire driver fees within the licensing section of the
9 records, elections and licensing services division.

10 B. These fees are authorized by the legislative authority of any county as allowed
11 by RCW 46.72.160.

12 SECTION 2. Ordinance 13334, Section 2, as amended, and K.C.C. 6.64.025 are
13 each hereby amended to read as follows:




