**Sponsors** Balducci

1           A MOTION confirming three corrected appointments for  
 2           the King County cultural development authority (4Culture)  
 3           board of directors; and rescinding Motion 16043, Motion  
 4           16451, and Motion 16494.

5           WHEREAS, the metropolitan King County council adopted Ordinance 14482 in  
 6           2002, which established the King County cultural development authority, 4Culture, to  
 7           continue support for cultural resources, including arts, heritage, historic preservation, and  
 8           public art, and

9           WHEREAS, Ordinance 14482 and the 4Culture Charter require the King County  
 10          council to confirm appointments to the 4Culture board of directors by motion, and

11          WHEREAS, the council adopted Ordinance 18684 in 2018, which amended the  
 12          4Culture charter and bylaws to change the board of directors appointment process to  
 13          require specific councilmembers to appoint nine specific board positions, and

14          WHEREAS, after Ordinance 18684, the numeric positions of the board of  
 15          directors did not correspond to the council district number of the councilmember  
 16          responsible for making the appointment, and

17          WHEREAS, the council adopted Ordinance 19036 in 2019, which amended the  
 18          4Culture charter and bylaws to change the position numbers of council-appointed board  
 19          positions to correspond to the council district number of the councilmember responsible  
 20          for making the appointment, and

21 WHEREAS, the 2019 changes to the numeric board positions were not reflected  
22 in three motions confirming appointments of three board members, which resulted in  
23 those board members being appointed to incorrect board positions, and

24 WHEREAS, Motion 16043, passed on February 22, 2022, confirmed Afua  
25 Kouyate, who was appointed from council district two, to an unspecified Board Position,  
26 and

27 WHEREAS, Motion 16451, passed on October 24, 2023, confirmed Staci Adman,  
28 who was reappointed from council district one, to Board Position 6, and

29 WHEREAS, Motion 16494, passed on November 28, 2023, confirmed Latha  
30 Sambamurti, who was reappointed from council district six, to Board Position 2, and

31 WHEREAS, the King County council wishes to rescind Motion 16043, Motion  
32 16451, and Motion 16494, and confirm the appointments of the three directors to the  
33 correct board positions;

34 NOW, THEREFORE, BE IT MOVED by the Council of King County:

35 A. The King County district two appointment of Afua Kouyate to Board Position  
36 2 of the King County cultural development authority (4Culture), for a three-year term that  
37 began on February 22, 2022, to expire on December 31, 2024, is hereby confirmed.

38 B. The King County district one reappointment of Staci Adman to Board Position  
39 1 of the King County cultural development authority (4Culture), for a three-year term, to  
40 expire on December 31, 2026, is hereby confirmed.

41 C. The King County district six reappointment of Latha Sambamurti to Board  
42 Position 6 of the King County cultural development authority (4Culture), for a three-year


43 term, to expire on December 31, 2026, is hereby confirmed.



**Electronic Record and Signature Disclosure**

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

### **Consequences of changing your mind**

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

### **All notices and disclosures will be sent to you electronically**

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

### **How to contact King County-Department of 02:**

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

### **To advise King County-Department of 02 of your new email address**

To let us know of a change in your email address where we should send notices and disclosures electronically to you, you must send an email message to us at [cipriano.dacanay@kingcounty.gov](mailto:cipriano.dacanay@kingcounty.gov) and in the body of such request you must state: your previous email address, your new email address. We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

### **To request paper copies from King County-Department of 02**

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to [cipriano.dacanay@kingcounty.gov](mailto:cipriano.dacanay@kingcounty.gov) and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

### **To withdraw your consent with King County-Department of 02**

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to [cipriano.dacanay@kingcounty.gov](mailto:cipriano.dacanay@kingcounty.gov) and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

### **Required hardware and software**

### **Acknowledging your access and consent to receive and sign documents electronically**

To confirm to us that you can access this information electronically, which will be similar to other electronic notices and disclosures that we will provide to you, please confirm that you have read this ERSD, and (i) that you are able to print on paper or electronically save this ERSD for your future reference and access; or (ii) that you are able to email this ERSD to an email address where you will be able to print on paper or save it for your future reference and access. Further, if you consent to receiving notices and disclosures exclusively in electronic format as described herein, then select the check-box next to ‘I agree to use electronic records and signatures’ before clicking ‘CONTINUE’ within the DocuSign system.

By selecting the check-box next to ‘I agree to use electronic records and signatures’, you confirm that:

- You can access and read this Electronic Record and Signature Disclosure; and
- You can print on paper this Electronic Record and Signature Disclosure, or save or send this Electronic Record and Disclosure to a location where you can print it, for future reference and access; and
