1 AN ORDINANCE authorizing the King County executive
2 to enter into amendments to interlocal cooperation
3 agreements with the cities of Normandy Park, Snoqualmie
4 and Seattle for the disbursement of conservation futures tax
5 levy funds appropriated under Ordinances 17073 and
6 17181.

7 **STATEMENT OF FACTS:**

- 8 1. King County conservation futures tax levy funds are collected
9 throughout King County as a dedicated portion of the property tax for the
10 acquisition of open space and resource lands.
- 11 2. Ordinance 14714 established procedures for the annual allocation of
12 conservation futures tax levy funds, which direct the conservation futures
13 citizens' committee to make funding recommendations to the King County
14 executive to consider for inclusion in the annual budget ordinance.
- 15 3. The executive received and considered the conservation futures
16 citizens' committee funding recommendations and included them in his
17 transmittal of the first and second fiscal quarter 2011 annual budget
18 supplemental ordinances, Ordinances 17073 and 17181, by which the
19 King County council appropriated 2011 conservation futures funds or

20 modified project scopes for the city open space projects listed and
21 described in Attachment B to this ordinance.

22 5. King County desires to disburse conservation futures funds to the
23 suburban cities and the city of Seattle, and to do so it must sign
24 conservation futures interlocal cooperation agreements or amend existing
25 conservation futures interlocal agreements with these jurisdictions.

26 6. The county and the cities are authorized to enter into an interlocal
27 agreement pursuant to chapter 39.34 RCW, the Interlocal Cooperation
28 Act.

29 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

30 SECTION 1. The King County executive is hereby authorized to enter into and
31 execute amendments to interlocal cooperation agreements containing language,
32 substantially similar to that in Attachment A to this ordinance, necessary for the

33 disbursement of conservation futures tax levy funds appropriated under Ordinances
34 17073 and 17181, as adopted by the King County council.



**AMENDMENT TO THE CONSERVATION FUTURES
INTERLOCAL COOPERATION AGREEMENT
BETWEEN KING COUNTY AND THE CITY OF _____
FOR OPEN SPACE ACQUISITION PROJECTS**

Preamble

The King County Council, through Ordinance 9128, has established a Conservation Futures Levy Fund and appropriated proceeds to King County, the City of Seattle and certain suburban cities. This amendment is entered into to provide for the allocation of additional funds made available for open space acquisition.

THIS AMENDMENT is entered into between the CITY OF _____ and KING COUNTY, and amends and attaches to and is part thereof of the existing Interlocal Cooperation Agreement entered into between the parties on the ____ day of (Month), (year), as previously amended.

The parties agree to the following amendments:

Amendment 1: Article 1. Recitals

A paragraph is hereby added to the Recitals Section to provide for a Conservation Futures Levy Fund allocation for the _____ Acquisition, and hereafter reads:

- On _____, 201_ the King County Council passed Ordinance _____, which appropriated a total of _____ (\$ _____) in Conservation Futures Levy proceeds to the City of _____ for the _____ acquisition Project. On _____, 201_ The King County Council passed Ordinance _____, authorizing the King County Executive to enter into interlocal agreements with the City _____ for the disbursement of Conservation Futures Funds appropriated in Ordinance _____.

Amendment 2: Article V. Conditions of Agreement

Section 5.1 is amended to include Attachment ___, which lists a 201_ Conservation Futures Levy Allocation for the _____ Acquisition project.

Amendment 3: Article VII. Responsibilities of County

The first two sentences of this article are amended to include references to Attachment ___, which lists a 201_ Conservation Futures Levy proceeds allocation for the _____ Acquisition Project:

Subject to the terms of this agreement, the County will provide Conservation Futures Levy Funds in the amounts shown in Attachments A through ___, to be

used for the Projects listed in Attachments A through __. The City may request additional funds; however, the County has no obligation to provide funds to the City for the Projects in excess of the total amounts shown in Attachments A through __. The County assumes no obligation for the future support of the Projects described herein except as expressly set forth in this agreement.

AMENDMENT 4: Attachment __

The Attachments to the interlocal agreement are hereby amended by adding Attachment __, which is hereby attached to the interlocal agreement, incorporated therein and made a part thereof.

In all other respects, the terms, conditions, duties and obligations of both parties shall remain the same as agreed to in the Interlocal Cooperation Agreement as previously amended.

This document shall be attached to the existing Interlocal Cooperation Agreement.

Suburban City CFT Projects:

Ordinance 17073:

315765 Snoqualmie Riverfront Reach (City of Snoqualmie)

2011: The scope of the Snoqualmie Riverfront Reach project is expanded to include additional properties lying along the Snoqualmie River. The area is identified in the City of Snoqualmie's plan for a riverwalk park along the Snoqualmie River. The city is unable to reach agreement with the owners of two properties originally identified in this project, and it has requested an expansion of the project scope to include additional properties.

Ordinance 17181:

315787 Normandy Park - Beaconsfield on the Sound

2011: \$563,000 in additional funding is provided to this Puget Sound shoreline acquisition project from Normandy Park's abandoned Walker Creek Preserve Project. This project has many parcels and owners. The project will provide additional public beach access, preserve scenic Puget Sound shoreline from development, and protect upland shoreline habitat. It will also help prevent the construction of additional shoreline bulkheads, and potentially allow for removal of some existing shoreline armoring, if that is found to be feasible.

Seattle Projects:

Ordinance 17181:

315404 Seattle - Thornton Creek Park 6 Natural Area

2011: This project is a one-parcel urban stream corridor acquisition project in north Seattle that is located three blocks from Northgate Mall. The project will receive an additional \$30,000 to help meet a project funding shortfall. The project site has a rare large Sequoia tree that will be accessible to the public.

315449 Seattle - Lake City Urban Village Park

2011: \$30,000 will be reallocated to this project to acquire a new .25 acre passive open space park site in the Lake City Hub Urban Village in Seattle. The project was funded last year and has a shortfall, and this reallocation from the abandoned Lake Forest Park 40th Place Greenbelt project, which is located a few miles north, will help meet the funding shortfall.
