3	business enterprises requirements, for repairs to protect life
4	and property threatened by the emergency conditions cited in
5	the Local Proclamation of Emergency issued by the King

9	WHEREAS, the King County executive issued a Local Proclamation of Emergency
10	on November 6, 2006, pursuant to chapter 38.52 RCW and K.C.C. chapter 12.52, and
11	attached to this motion and by this reference made a part of this motion, and the council
12	acknowledges receipt of the local proclamation of emergency, and
13	WHEREAS, weather conditions consisting of heavy rainfall creating record-
14	breaking flooding conditions in King County caused extensive damage to public property
15	and facilities, and
16	WHEREAS, persons and property have been and will be adversely affected unless
17	further efforts are taken to reduce the potential threat to life and public property, and

WHEREAS, the repair work to county roads and other public facilities must begin immediately to minimize the potential risk of personal injury and property damage, and

WHEREAS, the nonemergency requirements of K.C.C. chapter 4.16 relating to the county's lease or purchase of tangible personal property or services, contracts for public works as defined by RCW 39.04.010 or to the selection and award of professional and/or technical service consultant contracts; including contracting on a competitive basis for public works contracts, leases or purchase of supplies, materials and equipment pursuant to chapter 36.32 RCW and compliance with minority and women's business enterprises requirements pursuant to K.C.C. chapters 4.18, 12.16 and 12.18 for such repairs must be waived in order to prevent delay in beginning the repair work;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

A. The nonemergency requirements of K.C.C. chapter 4.16 relating to the county's lease or purchase of tangible personal property or services, contracts for public works as defined by RCW 39.04.010, or to the selection and award of professional and/or technical service consultant contracts; including contracting on a competitive basis for public works contracts, leases or purchase of supplies, materials and equipment pursuant to chapter 36.32 RCW for emergency repair, restoration or relief work, in order to prevent delay in beginning the work, are hereby waived.

B. The nonemergency minority and women's business enterprises requirements pursuant to K.C.C. chapters 4.18, 12.16 and 12.18 are hereby waived as to the individual project contracts, provided that the emergency waiver of the requirements of K.C.C. chapters 4.18, 12.16 and 12.18 pursuant to this motion shall not amend the annual

40 utilization goals unless the emergency makes it impossible to achieve the annual utilization 41 goals. C. LOCAL PROCLAMATION OF EMERGENCY

WHEREAS, the King County Office of Emergency Management has reported to the King County Executive that unusual weather conditions consisting of heavy rainfall with a forecast of record stream flows and urban flooding are causing an emergency by creating damage, residential evacuations, and possible injury in King County; and

WHEREAS, persons and property are and will be threatened and damaged unless further efforts are taken to reduce the threat to life and property; and

WHEREAS, this disaster is causing an undesignated amount of damage; and

WHEREAS, the severity and magnitude of this disaster is beyond the response and recovery capability of local resources; and

WHEREAS, there is an emergency present which necessitates activation of the King County Emergency Operations Plan and utilization of emergency powers granted pursuant to RCW Chapter 38.52. and K.C.C. Chapter 12.52; and

WHEREAS, the emergency may require emergency purchases by King County and the waiver of public procurement processes as described under K.C.C. Chapter 4.16.050, therefore

BE IT PROCLAIMED BY THE KING COUNTY EXECUTIVE, RON SIMS

SECTION 1

That it is hereby declared that there is an emergency due to rain, flooding and other secondary hazards affecting King County; therefore designated departments of King County are authorized to enter into contracts and incur obligations necessary to combat such emergency to protect and provide emergency assistance to victims of such emergency.

SECTION 2

Each designated department is authorized to exercise the powers vested under Section 1 of this Resolution in light of the exigencies of an emergency situation without regard to time consuming procedures and formalities prescribed by law (excepting mandatory constitutional requirements).
