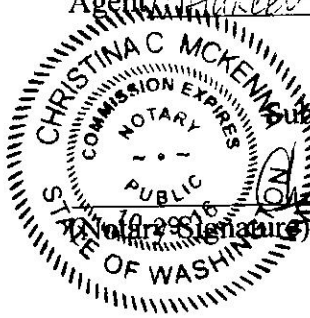

NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington, on the 18th day of February, 2014, at 1:30 p.m., to consider adoption of Proposed Ordinance 2014-0067, an ordinance dissolving the King County Transportation Benefit District, a transportation benefit district comprised of only the unincorporated area of King County, as created under Ordinance 16742. The ordinance is proposed for emergency action in order for the dissolution to be effective prior to the establishment of a countywide transportation benefit district.
