

# Sims appoints Reed Holtgeerts as jail director

King County Executive Ron Sims today appointed Reed Holtgeerts to serve as director of the Department of Adult and Juvenile Detention. Holtgeerts is a 28-year veteran of the department, most recently serving as deputy director.

"Reed's in-depth knowledge of the corrections field and strong management skills make him uniquely qualified to lead the department," said Sims. "He is an amazing success story, having earned the respect and admiration of line staff and managers as he advanced from corrections officer to deputy director. Reed has an impressive track record of working effectively with staff to put in place innovative practices."

Holtgeerts joined the department in 1976 as a corrections officer. He was subsequently promoted to positions of corrections sergeant, lieutenant/captain, and corrections major. In 2000 Holtgeerts was named facility commander at the Regional Justice Center, and served in that position until he was named deputy director for the department. In 2001, Holtgeerts graduated from the National Institute of Corrections Executive Excellence Program.

"After many years of service to the department, it is an honor and privilege to accept the position of director," said Holtgeerts. "The department has outstanding employees and one of the top corrections management teams in the country. Together we will continue to be a leader in this region for corrections services."

"Reed has worked with our civic and business leaders to ensure that the Regional Justice Center remains a positive part of our community," commented Mayor Jim White, City of Kent. "We look forward to continuing this relationship with Reed in addressing corrections issues in our region."

Upon hearing his appointment, Sheriff Sue Rahr said "Reed is the person you want at the table to collaboratively solve problems and prepare for the future. He will be an excellent partner with law enforcement on regional efforts to make improvements in the criminal justice system."

Holtgeerts' appointment will be sent to the County Council for confirmation.

Congratulations! This is to confirm my job offer and your acceptance of the position of Director of the King County Department of Adult and Juvenile Detention (DAJD), effective Tuesday, February 1, 2005. Your appointment is subject to future confirmation by the King County Council.

Your assignment will be to the DAJD Administrative Offices, Room E-245 of the King County Courthouse. On a day to day basis you will report to Sheryl Whitney, Assistant King County Executive. Your annual salary will be \$135,400.93, which is Salary Range 87, Step 10 (King County 2005 FSLA Exempt Squared Schedule.) You are eligible for continuation of all insured and leave benefits.

This position is a career service exempt position, which means it is not covered by the County's career service system. This position is not represented by a union. As a career service exempt employee, you are an at-will employee and serve at the pleasure of the appointing authority. You may be terminated from employment at any time without cause.

This position has a standard 40-hour workweek and is exempt from the overtime provisions of the Fair Labor Standards Act (FLSA). All FLSA overtime exempt employees are expected to work the hours necessary to satisfactorily perform their jobs. FLSA overtime exempt employees are paid on a salary basis and are not eligible for overtime pay or compensatory time accrual. However, pursuant to Executive Policy, PER 8-1-1, you may be eligible for up to 10 days of executive leave.

Please understand that the provisions of this letter do not constitute an express or implied employment contract, but are simply statements of information that are important for you to know.



# POSITION DESCRIPTION: DIRECTOR, KING COUNTY DEPARTMENT OF ADULT AND JUVENILE DETENTION

The Director of DAJD reports to the King County Executive and Assistant County Executive. The position directs the overall planning and operations of a large, urban multi-facility and multi-program correctional services system providing pre-trial services and a range of both secure and community-based alternatives to adult and juvenile detainees. It is responsible for the safe, secure and humane detention of King County adult felons and misdemeanants, both pretrial and sentenced for one year or less; and it administers jail services contracts with 37 municipal jurisdictions in King County to house pretrial and sentenced misdemeanants.

DAJD comprises five divisions: the King County Correctional Facility (KCCF) in downtown Seattle, the Regional Justice Center (RJC) in Kent (also known as the Youth Services Division), the Juvenile Detention Division (JDD) on Alder Street in Seattle, the Community Corrections Division (CCD) in downtown Seattle and the Administrative Division. Adult corrections staff supervise an average daily population of 2,500 in two secure detention facilities and community corrections programs. Juvenile Division staff supervise an average daily population of 116 in secure detention, day and evening reporting and a specialized non-offender unit for children at risk or children in need of services. The Community Corrections Division is a key subordinate unit in the office of the King County Executive. DAJD provides administrative support and administers the Division's budget.

The successful candidate will provide oversight of all day-to-day operations via two Jail Commanders, a Chief of Administration and one Juvenile Division Manager and will provide ongoing administrative support for the Community Corrections Division Manager. The position represents the King County Executive on correctional issues in the community and with media representatives. The position is responsible for the operations of a County department with a 2004 budget of \$95 million and an authorized and budgeted staff of 937 employees. The majority of staff are members of collective bargaining units. The Director is responsible for directing collective bargaining activities.

#### The selected candidate shall:

- 1. Operate exemplary detention facilities and programs that are based on sound practices and integrate effectively with criminal justice, health and treatment systems.
- 2. Maintain effective, collaborative working relationships with labor representatives, local and national criminal justice system officials, King County elected officials, and members of the Executive Cabinet, and other stakeholders in the adult and juvenile detention area.
- 3. Develop, defend and manage the Department's annual budget.
- 4. Devise creative, efficient solutions to resolve operational challenges and address the systemic pressures associated with rapid, continuing growth in the inmate and juvenile detainee populations.
- 5. Provide leadership in developing and conveying an organizational vision and mission; and
- 6. Implement organizational change in alignment with Executive priorities and sound correction practices.



### DEPARTMENT OF ADULT AND JUVENILE DETENTION

The 2004 annual salary range for the Director of DAJD is \$104,535 to \$132,504. The County provides medical, dental, vision, term life and accidental death and disability benefits. The Director will be a member of a public retirement benefit program operated by the State of Washington.
