## Land Use Appeals - Items 32-35

*Darren Carnell, Supervising Attorney, Prosecuting Attorney's Office, gave an overview of the Council's role in the quasi-judicial process.*

*Councilmember Perry made the following statement for the record. "Before the Council considers this land use appeal, I want to provide a little information about my review as well as some other issues related to Fall City. I understand that it is Council's obligation to review these vested plat applications based on the record the parties developed before the Hearing Examiner and I have made my best effort to do that. As everyone knows, there has been ongoing legislative activities regarding the future of Fall City. The 2016 Comprehensive Plan divided the county into seven community service areas and established a schedule for the development of a new subarea plan for each area. Since June of 2020, the County has been working on a new subarea plan for Snoqualmie Valley - Northeast King County, which includes Fall City. The new subarea plan is expected to be adopted in December 2024. Earlier this year the County adopted a moratorium to limit the ability of new projects to vest to the old code. This legislation was intended to allow the future of Fall City to be guided by the new plan and regulations. Of course, applications that were previously vested will be continue to be reviewed under existing regulations. In my ongoing work for the subarea plan, I directed staff in my office to screen me from any written communications about the projects that are on appeal here. My staff and I were also very careful to be clear that conversations about ongoing plat applications and appeals were not something that I could discuss. I reviewed the briefs in this land use appeal, and I am not aware of any facts or arguments about the proposed plats that are not contained in the briefing. This reinforces for me that my office's screening system worked, and I have not inadvertently learned anything about the proposed plats other than what the parties have presented and is in the record. I am looking forward to hearing the arguments today."*

*Councilmember Balducci made the following statement for the record. "I would also like to provide some information about my review of this appeal and some other issues related to Fall City. Like Councilmember Perry, I understand our obligation as a Council to review these proposed plats and these appeals based on the record before the Hearing Examiner, and I of course am making my best effort to do that. As you all know, there has been ongoing discussion and legislative activity regarding the future of Fall City. The County has been working on a new subarea plan for the area. Earlier this year we adopted a moratorium to limit the ability of new projects to vest to the current version of the county code while the planning process was completed. Of course, applications that are previously vested will continue to be reviewed under existing regulations. In the course of my learning about this situation and considering the moratorium, in April of this year I took a drive in my car through Fall City, so I could see the area for myself. Councilmember Perry's office provided a map to help me find some of the locations in question and I was able to view them from my car. I did not meet or talk with anyone while I was there. In fact, I didn't get out of the car. I just wanted to see the signs and what was going on the area. Later in August I had one 30-minute meeting online with representatives of the building industry. An employee of Taylor Development was invited to that meeting but did not attend. I've also received a number of emails from I believe just in the course of business that we all have received, but none of those were about these plat appeals. As I must, I will confine my decision making to the briefs in this land use appeal. I am not aware of any facts or arguments that are outside of the briefing and unless there are any questions that is the disclosure I would like to make before we get into the hearing."*

*Councilmember Dembowski stated for the record that because of the ongoing legislative work and the moratorium that was advanced, his office received emails from people who he believed live in or have an interest in these issues in the Fall City Area. He did read the emails but did not know the status of these appeals or that there was any issue before the Hearing Examiner. The emails seem to be related to the moratorium and he does not know if any of those people who emailed his office are a part of this appeal or a member of the organizations that are doing these appeals. He also stated that he had a recent meeting, related to the moratorium legislation, with the master builders of King and Snohomish County, and there was no representative of either party present nor they did not talk about this appeal in that meeting.*

*David Spohr, Hearing Examiner, summarized the appeal and recommendations and answered questions.*

*Michael Rea and David Bricklin, Attorney's for the Appellant, Fall City Sustainable Growth, presented and answered questions of the Council.*

*Patrick Mullaney, Attorney for the Applicants, Slalom 13 LLC, Cedar 17 LLC, Cha Cha LLC, and Mt. Si LLC, presented and answered questions of the Council.*
