8 Washington has made an affidavit, Attachment A to this motion, in accordance with
9 RCW 84.56.240 and 84.56.260, to the King County council relating his diligent search
10 and inquiry for goods and chattels of the persons appearing on the list of delinquent
11 taxpayers, Attachment B to this motion, and his inability to find any such property from
12 which the taxes could be collected, and

13 WHEREAS, the duly appointed manager of treasury operations of King County,
14 Washington, has requested the authority from the King County council to cancel the
15 taxes;

16 NOW, THEREFORE, BE IT MOVED by the Council of King County:

17 The manager of treasury operations of King County is hereby authorized to cancel
18 the tax billings listed in Attachment B to this motion in the amount of \$125,458.78 from
19 the records of treasury operations for the years 1994, and 1996 through 2001, but the
20 obligation to King County is not forgiven.





8 affidavit pursuant to the terms of RCW 84.56.240 and RCW 84.56.260.


