1 AN ORDINANCE relating to the county property tax
2 levies for collection in 2012, and implementing RCW
3 84.55.120.

4 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

5 SECTION 1. The council is under an obligation by charter to enact revenue
6 measures that support the budget appropriation ordinance by December 1, 2011, for the
7 2012 budget. This ordinance sets the amount of property tax to be collected for the
8 regular property tax levy, the road district levy, the conservation futures levy and the
9 emergency medical services levy. In accordance with RCW 84.55.120, the council has
10 given proper notice of this ordinance to the public.

11 SECTION 2. For collection of the property tax levies in 2012, the council hereby
12 authorizes property tax increases over the amounts authorized for collection in 2011 as
13 follows:

Levy	Estimated Dollar Increase	% Increase	Estimated Total Levy
Regular	\$4,548,579	1.21%	\$385,155,400
Regular - Transit	\$852,970	3.77%	\$23,669,100
Road District	-\$13,076,057	-15.19%	\$73,643,200

Conservation Futures	\$34,849	0.20%	\$17,378,700
Emergency Medical Services	-\$5,055,159	-5.13%	\$94,651,100

- 14 The increases shown above are exclusive of any amounts resulting from new construction
15 valued in 2011, any increases in value of state-assessed property for 2011 and any
16 amounts necessary to fund tax refunds paid in 2011.

17 SECTION 3. Upon enactment of this ordinance, the clerk is directed to forward
18 this ordinance to the assessor in accordance with RCW 84.52.070.


