8	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:	
9	SECTION 1. Findings:	
10	A. The city of Federal Way, Washington, by Resolution No. 04-423, has	
11	determined that it is in the public interest and general welfare to provide for the	
12	annexation of an area known as the Redondo East annexation area, in accordance with	
13	chapter 35A.14 RCW.	
14	B. City of Federal Way Resolution No. 04-423 satisfies the provisions of chapter	•
15	35A.14 RCW for qualification for annexation.	
16	C. The city of Federal Way, by Resolution No. 04-423, initiated the annexation	
17	of the Redondo East annexation area.  KING COUNTY RECORDS, E  AND LICENSING SERVI  Election Section	LECTIONS

18	D. The King County boundary review board received a request for review under
19	chapter 36.93 RCW, and on July 23, 2004, the review board, in file 2174, deemed the
20	proposed city of Federal Way Redondo East annexation file approved.
21	E. Pursuant to chapters 29A.04 and 35A.14 RCW, the metropolitan King County
22	council deems an emergency exists for the purpose of calling a special election to be held
23	on the question of this annexation on November 2, 2004.
24	SECTION 2. A special election shall be held on the 2nd day of November 2004
25	in accordance with chapter 35A.14 RCW within the territory of the proposed annexation,
26	for the purpose of submitting the question of annexation of the Redondo East annexation
27	area.
28	SECTION 3. The number of registered voters within the subject area is estimated
29	at 154 as nearly as may be determined from available records.
30	SECTION 4. Pursuant to RCW 29A.04.321 and 35A.14.050, it is hereby deemed
31	that an emergency exists for purposes of calling a special election. The King County
32	director of the records, elections and licensing services division is hereby requested to
33	assume jurisdiction to call and conduct a special election and submit to the registered
34	voters within the subject area of the propositions as set forth in section 4 of this
35	ordinance. The clerk of the council is hereby authorized and directed to transmit these
36	propositions to the director of records and elections in substantially the following form,
37	with such additions, deletions or modifications in the ballot title as may be required for
38	the propositions listed below by the King County prosecutor:
39	PROPOSITION 1: The City Council of the City of Federal Way, Washington,
40	adopted Resolution No. 04-423 concerning a proposed annexation of the Redondo East

41	annexation area. If approved, this proposition would annex an area of unincorporated
42	King County contiguous to the City of Federal Way's western boundary and commonly
43	known as the Redondo East annexation area, which is legally described in City of Federal
44	Way Resolution No. 04-423. Upon annexation, the area shall have imposed the City of
45	Federal Way Comprehensive Plan designations and zoning classifications as adopted in
46	City of Federal Way Ordinance No. 04-460. Should this annexation and adoption of
47	proposed zoning regulation be approved?

51	PROPOSITION 2: Shall all property within the proposed Redondo East
52	annexation area, upon annexation, be assessed and taxed at the same rate as property
53	located within the City of Federal Way is assessed and taxed to pay for all or any portion
54	of the then outstanding indebtedness of the City, which indebtedness has been approved
55	by the voters, contracted for, or incurred prior to, or existing at, the date of annexation?

58	SECTION 5. The boundaries of the territory proposed for annexation are hereby
59	described in city of Federal Way Resolution No. 04-423 as contained in Attachment A to
60	this ordinance.
