5. **Reports on Special and Outside Committees**

Ms. Patterson reported on the Board of Health. The members discussed issues regarding domestic violence, tobacco regulations, nutrition in schools and the upcoming legislative session. The Board took action on regulations that will tighten the enforcement of the laws in place due to Initiative 901, banning smoking in public places. The Board had a briefing from Tom Bristow, Government Relations Consultant, regarding legislative priorities relating to health.

Ms. Patterson reported on the recent meeting of the South County Area Transportation Board, indicating that the members focused their discussion on Metro service partnerships.

Mr. Phillips reported on the Sound Transit Central Link Oversight Committee which meets to ensure the link light rail system comes in on time and on budget. At the last meeting, the committee heard a construction progress report from Ahmad Fazel, Link Light Rail Executive Director, on the segment being built from Tukwila to downtown Seattle. The next meeting will be on November 15.
