C3 Proviso Report

Update on Report Stimulus – C3 Proviso Report

This is an update to King County Ordinance 18295, Section 2 requesting the executive undertake one or more pilot projects to use the C3 [fiber optic network around Lake Washington] to expand access to high-speed broadband service within the unincorporated areas of King County that have been underserved by high-speed digital technology.

Criteria for School Participation (used KC ESJ, WA Office of Superintendent of Public Instruction, and federal broadband data)

- Greater than 50 percent of Schools students populations receives free and reduced priced lunch
- Communities have limited communications infrastructure (Internet at home, fiber, cellular coverage)
- Areas where families earn less than \$50,000 per year or where annual household median income is less than \$50,000 per year (i.e. 200 percent of the U.S. poverty level)
- Schools are within the targeted communities of Best Start for Kids, Community of Opportunities (OCC), Youth Action Plan programs and County's ESJ
- The above criteria aligns with directions in King County Ordinance 18295, Section 2

Dimmitt Middle School – Selection based on above criteria and alignment with their 1:1 laptop program


Initial Implementation –Renton School District's new 1:1 laptop program provides students in 8th grade with a new laptop for access to school assignments, homework online and other school resources. District conducted surveys of student at Dimmitt shows up to 25% of students don't have internet at home.

Implementation Planning during Summer Break

- School purchasing laptops
- Complete testing of connections w/school laptops
- After successful test, activate devices & data plans
- School roll out laptops for start of school year
