SUMMARY
The Washington State Growth Management Act (GMA) authorizes local jurisdictions to callect impact fees as a method of financing public facilities (i.a., roads, parks and open spece, schools) that become necessary as a result of new growth and development.

King County administers the School Impact Fee Program by collecting fees from residential developers on behalf of each school district that chooses to participate (the program is voluntary). The fees are developed by the individual school districts in accordance with provisions in state law and the King County Code, and are sel forth in the districts' capital facilities plans. The plans (and fees) are reviewed and adapted by the King County Council.

Proposed Ordinance 2021-0365 amends Tillo 20 to update the school capital facilities plans and Title 27 to implement the collection of impact fees by the county on behalf of the following school districts, effective January 1, 2022:
