Ordinance 19277

NOTICE IS HIREBY GIVEN that the Metropoliton King County Council (the Council) held a public hearing on Tuesday, April 27, 2021, beginning of 1:09 P.M. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2021-0024, adopting amendments to King County Code 13.24.035 related to sew it service eligibility in the Vashon and Snoqualmite Pass rural towns. The Council adopted the legislation of that meeting.

SUMMARY:
The Washington State Growth Management Act (GMA) lightly restricts provision as sewer structe outside the Urban Growth Area oundary. While all of Vashon-Maury sland is leacted outside of the Urban Growth Area and is considered rural in nature, the King County Comprehensive Plan and King County Code rucognize concentrations of higher density and economic activity in the Rural Area that existed prior to the adoption of the Growth Management Act by allowing rural towns, such as the Vashon Rural Town and the Snagualmie Pass Rural Town, to have urban-style levils of density and development, including sewer.

Ordinance 19217 amends Title 13 to

Ordinance 19217 amends Title 13 to clarify that expanding the area eligible for sewer service within the Vashon Rural Town reaulies a separate and distinct action from changing the Vashon Rural Town boundary, and that the Snoaualmile Pass Rural Town is also approved for sewer service. The legistation also clarifies that the Snoaualmile Pass Rural Town has also been approved for sewer service and must only provide sower service to areas within the Rural Town boundary.
