6 Section 113, Proviso P1, as amended by Ordinance 19364, states that \$600,000 of the
7 funds appropriated to transit from the public transportation operating fund shall not be
8 expended or encumbered until the executive transmits a RapidRide restart report detailing
9 progress on efforts to resume previously paused RapidRide bus rapid transit lines and a
10 motion acknowledging receipt of the report is passed by the council, and

13 WHEREAS, the report is submitted by the Metro transit department's mobility
14 division to fulfill the proviso's reporting obligations;


