1           A MOTION relating to the appointment of Anton Zgraggen  
2           to the board of commissioners of King County drainage  
3           district No. 2.

4           WHEREAS, King County drainage district No. 2 is authorized to undertake  
5 drainage control, storm water control and surface water control activities, including  
6 acquisition and maintenance of drains, ditches, canals, nonsanitary sewers, pumps and  
7 other works and appliances, machinery and equipment, and

8           WHEREAS, the jurisdiction of the district is generally bounded by the Green  
9 river, Orillia Road and 42nd Avenue South, the Tukwila 205-Cutoff Levee to Southcenter  
10 Parkway at river mile 16.7 and just north of Veterans Drive in Kent. A map of the  
11 district is attached as Attachment A to this motion, and

12           WHEREAS, the district is governed by a three-member board of commissioners,  
13 each of whom must be a "qualified voter of the special district," as required by RCW  
14 85.38.010(3), and

15           WHEREAS, Anton Zgraggen is a registered voter and owns lands with the district  
16 and thus meets the qualifications to serve as a member of the district's board of  
17 commissioners, and

18           WHEREAS, a vacancy exists on the district's board of commissioners and the  
19 county council is authorized to appoint a commissioner to fill the vacancy as provided by  
20 RCW 85.38.070(5);

21           NOW, THEREFORE, BE IT MOVED by the council of King County:

22           Anton Zraggen is hereby appointed to fill vacancy of Position 2 on the King

23 County drainage district No. 2 board of commissioners and once qualified to serve until a

24 successor is elected at the next district general election and qualified. The appointee shall

26 requirements of RCW 85.38.080 and which shall be filed with the clerk of the council.


