NOTICE IS HEREBY GIVEN that a notice of intention has been filed with the King County Council relating to the withdrawal of approximately 247 acres of land from the Sammamish Plateau water and sewer district to the city of issaquah, for the purpose of water service. A public hearing before the Metropolitan King County Council will be held at the King County Courthouse, 516 3rd Avenue Room 1001, on Tuesday, September 13, 2022, at 1:00 p.m.; remote public testimony on Zoom will be accepted.
