NOTICE IS HEREBY GIVEN that a notice of intention has been filed with the King County Council relating to the removal of approximately 80 acres of land from the Ames Lake water association and annexation into the Sammamish Plateau water and sewer district, known as the M-Brooke Farm Water Annexation, for the purpose of water service. A public hearing before the Metropolitan King County Council will be held at the King County Courthouse, 516 3rd Avenue Room 1001, on Tuesday, September 27, 2022, at 1:00 p.m.; remote public testimony on Zoom will be accepted. A description of the proposed area to be withdrawn is as follows:
