NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing on Tuesday, November 22, 2022 beginning at 1:00 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2022-0162 (Ordinance 19555) an ordinance adopting 2022 amendments to the 2016 King County Comprehensive Plan (Comprehensive Plan), including the proposed adoption of the Skyway-West Hill Subarea Plan and North Highline Subarea Plan as an amendment to, and element of, the Comprehensive Plan. The Council the adopted this Ordinance at the Tuesday, December 6, 2022 meeting.

SUMMARY:
The Comprehensive Plan is the guiding policy document for all land use and development regulations in unincorporated King County. Ordinance 19555 adopted the Skyway-West Hill Subarea Plan and North Highline Subarea Plan, revised Comprehensive Plan policies related to the subarea plans adoption, and adopted land use and zoning map mendments, two new special district overlays, and new inclusionary housing regulations for these subareas. It also modified the schedule for the overall subarea planning program schedule.
